This funding is to be used to support costs associated with the change of delivery due to COVID. There are enough requests to expend the budget.</li> <li>HEERF (3) – \$1,017,10 budgeted, \$2,297 expended, \$1,014,804 remaining balance. This funding can be used to defray cost, including loss of revenue.</li> <li>COVID relief from GOV - \$20, 130,000. This funding must be spent by November 30. Funding is for IT upgrades, student housing augmentation, janitorial services, supplies for COVID.</li> <li>Ko is writing for additional CARES funds.</li> </ol></li></ul>

The survey responses were reviewed by KIAC and results shared with the Steering Committee in June.
