

## Class Delivery Modes - Fall 2020

- 1. 100% Synchronous Online Class (via Web-conferencing like Zoom, Google Hangouts, or RealPresence)**
  - a. Web conferencing sessions will mirror traditional F2F meeting schedule (100% of seat time).
  - b. 100% synchronous classes will follow F2F guidelines and attendance requirements.
    - i. Ex. Instructors are responsible for proctoring and proctored tests.
    - ii. Ex. Final exam schedule
  - c. Inform your students that class will be held via Zoom/Google Hangouts/Real Presence and the required tools necessary to participate.
  
- 2. 100% Asynchronous Completely Online Class (via Laulima)**
  - a. This is the traditional “online” classes that do not have any in-person or virtual session requirements other than proctored activities.
  - b. Inform your students that class will be held completely online and the required tools necessary to participate.
  
- 3. Blended Synchronous/Asynchronous Online Class (ex. Zoom/Laulima)**
  - a. Web conferencing sessions will be reduced (usually 50% of seat time) and the remainder of instruction held online.
  - b. Blended Synchronous/Asynchronous Online classes will generally follow F2F guidelines and attendance requirements.
    - i. Ex. Instructors are responsible for proctoring and proctored tests.
    - ii. Ex. Final exam schedule
  - c. Inform your students that class will be held via Zoom/Google Hangouts/Real Presence and the required tools necessary to participate.
  
- 4. Blended F2F/Asynchronous Online Class (ex. F2F/Laulima)**
  - a. Web conferencing session will be reduced (usually 50% of seat time) and the remainder of instruction held online.
  - b. Blended Synchronous/Asynchronous Online classes will generally follow F2F guidelines and attendance requirements.
    - i. Ex. Instructors are responsible for proctoring and proctored tests.
    - ii. Ex. Final exam schedule
  - c. Inform your students that class will be held via Zoom/Google Hangouts/Real Presence and the required tools necessary to participate.
  - d. Blended F2F/Asynchronous Online classes will generally follow F2F guidelines and attendance requirements..
    - i. Ex. Instructors are responsible for proctoring and proctored tests.
    - ii. Ex. Final exam schedule
  - e. Inform your students that class will be held both in person and online via Laulima, and the required tools necessary to participate.

**5. Blended F2F/Synchronous Online Class (ex. F2F/Zoom)**

- a. For delivery modes with a F2F component, need to consider how you will accommodate room capacity and social distancing requirements. For example, meet with ½ of class on Monday and ½ of class on Wednesday. (Although to be fair, assignment deadlines should also be staggered)
- b. A social distancing plan needs to be submitted and approved.
- c. F2F sessions will be reduced (usually 50% of seat time) and the remainder of instruction held via Zoom.
- d. Note: Blended classes are more than just “students doing homework and other assignments online.” If it was “homework” in a regular F2F class, it does not count toward the reduced F2F class time.
- e. These Blended Synchronous classes will generally follow F2F guidelines and attendance requirements.
  - i. Ex. Instructors are responsible for proctoring and proctored tests.
  - ii. Ex. Final exam schedule
- f. Inform your students that class will be held both in person and via Zoom, and the required tools necessary to participate in the Zoom sessions.

**6. Continuing classes with all scheduled F2F/vid-con meetings, but add synchronous online as an additional “location” (Taking a regular vidcon class and adding an additional CRN for students to connect from home via Zoom)**

- a. For delivery modes with a F2F component, need to consider how you will accommodate room capacity and social distancing requirements. For this delivery mode, the accommodation will be done through spreading out students over locations.
- b. Additional section of class will be for students attending via Zoom.
- c. Follows published final exam schedule
- d. For testing:
  - i. Students in the section where the instructor is located will generally follow F2F guidelines and attendance requirements..
  - ii. Students at other campus sites, and in the Zoom section will follow DE testing guidelines (instructors can choose to have students test at Testing Centers).
- e. Inform students in the Zoom section the required tools necessary to participate.

**7. Continuing classes with all scheduled on-campus meetings (regular F2F, vidcon classes)**

- a. This should be the last option, and special permission required.
- b. Class caps may need to be adjusted to allow for social distancing; special permission required.
